It is constituted with a commitment for rural and urban development in Uttara Kannada and surrounding districts in Karnataka State with a focus on communities' participation in management of natural resources and livelihoods sustainably through development approach and activities. Since 2005, organization is striving hard to operationalize and achieve its objectives of enhancing and diversifying livelihood opportunities for the rural poor by strengthening the households and communities, especially of tribal and marginalized communities with an integrated development approach and through promoting enterprises to improve the quality life. With the implementation of various development projects with multidisciplinary approach the organization is reaching many households in many districts of Karnataka, i.e., Uttara Kannada, Shimoga, Tumkur, Davanagere, Mandya, Ramanagara, Udupi, Bijapur, Belgaum, Bidar, Gulburga, Ballari and Chikkamagalur districts

- To develop innovative approaches for watershed area treatment and promotion of rain water harvesting to catch every drop of water where it falls.
- To promote people's organization for sustainable transformations of households and communities in rural and urban areas.
- To establish educational opportunities and ensure they are getting technical inputs by children of target households and communities.
- To involve women in community organization and decision making and empowering them to play their role effectively in the society for welfare of households and communities.

## Operational Area

The activities of the organization have now spread mainly in twelve districts in Karnataka State, i.e., Uttara Kannada, Shivamogga, Tumkur, Davanagere, Haveri, Mandya, Udupi, Ramanagar, Bijapur, Belgaum, Bidar, Gulburga, Ballari and Chikkamagalur districts and 4 harbours of Goa State namely Malim, Vasco-Da- Gama, Panaji & Cutbond harbours.

## Projects under Implementation

### **I. Education & Empowerment of Children and Youth**

#### **CHILDLINE-1098 Sub-Centre, Sirsi: Project under Women & Child Development Department:**

CHILDLINE 1098 is a national, 24 hour, free, emergency phone and outreach service for children in need of care and protection, linking them to long term rehabilitation. Set up in 1996, CHILDLINE is now operational in 366 cities / districts across 34 states and UTs in India. CHILDLINE India Foundation (CIF) provides the toll free phone service across India, monitoring the delivery of the service to the callers, financing the operation and training of personnel in order to provide relief and rehabilitation to children in distress.

Our organization has been selected for the CHILD LINE-1098 project on 27<sup>th</sup> December 2017 to set up the CHILDLINE sub-centre unit in Uttara Kannada (Karwar) district, Karnataka State. In 2018-19, total 128 cases have been registered in Uttara Kannada district.

### **Out Of School Children (OOSC) – 6 month residential Centre**

We have implemented 6 months residential Centre for Out Of School Children (OOSC) to school for the year 2018-19 under 6 month seasonal residential centre to 50 students at Sevanagara, Harappanahalli Taluk, Davangere.

### **OOSC Identified through census categorised as under**

- The never enrolled children who are in the age group of 7-14 years.
- The dropouts from schools at various stages of school, in 7 to 14 years age group.
- Seasonal bridge courses of 6 months duration for children of potential migrants in search of employment (out migration).
- Residential bridge courses for both never-enrolled and drop-out children so as to mainstream them to regular schools.

## **II. Women Empowerment & Gender Equity**

### **a) Formation and Strengthening of SHGs**

Women are organized in Self-Help Groups. They are provided various trainings for the capacity building and gender equity. Taluk wise details as given below;

Capacity development trainings on leadership skills have been conducted for the members of SHGs at Maratikoppa, Sirsi & Siddapur attended by more than 1000 Self Help Group members. Orientation on legal literacy & various skill development workshops were organized to SHG members & at the same time Income Generation Activity trainings were taken up on various skills such as Agarbatti making, Candle making, Garland making, etc. SHG members are empowered to establish business and enterprising ventures for making their livelihood on sustainable basis. Financial support in the form of loan is provided by NABFINS to start small commercial setup of their own choice.

### Micro Finance

Microfinance is the provision of a wider range of financial services to the poor having “**enormous potential as a tool for poverty alleviation**”. Formation of SHG of the same Socio-economic background who come forward voluntarily to work together for their own up-liftment & to teach among its members sound habits of thrift, savings & regular banking activities. They are trained to become cohesive as a group through regular meetings & encouraged to cultivate saving habit. Capacity building programs imparted to the group members, various skill training programs are organized to encourage them to start economic activities or to undertake self-employment ventures. Forming & nurturing small SHGs & to make them powerful tool for human development is a long-term process wherein one need spend time and over time review the results through studies. This process enables the poor especially the women from the poor households to collectively identify & analyses the problem they face in the perspective of their social & economic development for solving their own financial problems.

#### **b) Formation & Financing of Joint Liability Group (JLG) under National Bank For Agriculture & Rural Development (NABARD)**

Joint Liability Group (JLG) is a group of 4-10 people of same village/locality of homogenous nature and of same Socio Economic Background, who mutually come together to form a group for the purpose of availing loan from a bank without any collateral.

- Providing credit plus approach to increase their income levels & ensuring better loan recoveries.
- Providing Collateral free Loan to Groups
- To build mutual trust & confidence between bank & the target group.
- To mitigate the credit risk by way of group dynamics, peer pressure, credit discipline and cluster approach.
- To provide sustainable livelihood opportunities to vulnerable section for enhanced productivity & livelihood promotion through JLG mechanism

### **c) Santvana Mahila Kendra**

Counseling for the victims of domestic violence & to provide legal assistance, temporary shelter, financial relief, training and rehabilitation to women who are victims of various atrocities such as dowry, rape, sexual harassment, domestic violence etc. Santvana centre is provided with a toll free number 1091. The helpline receives calls from women in distress round the clock. Facilities and rehabilitative services are provided to such women as per the recommendations of the District Level Committee depending on the merits of the case. Santvana Mahila Kendra started from February 2015, at Haliyal taluk, Uttara Kannada district

### III. Health, Sanitation & Environment

SCODWES have implemented 04 Mobile Medical Unit from June 2016, under national Health Mission & SCP & TSP, Dept. of Health & Family Welfare, Mobile Medical Unit implemented at Mayakonda, Jaglur, Kudligi and Sandur of Davanger and Ballari taluk of Davangere & Ballari district, under which the allotted villages & nearly 90 villages have been provided with primary medical services.

SCODWES have implemented 04 Mobile Medical Unit from November 2016, under national Health Mission Dept. of Health & Family Welfare, Mobile Medical Unit implemented at Sirsi, Yellapur, Ankola and Joida of Uttara Kannada district, under which the allotted villages & nearly 80 villages have been provided with primary medical services.

#### Objectives of the Mobile Medical Unit Program

- To provide Primary, Preventive, Curative and Promotive health care services and referral health services to the people in the designated area.
- To co-ordinate with the District Public Health Systems to achieve improvement in the Millennium Development Goals such as IMR, MMR, Life expectancy, etc.
- To Prevent and Control communicable diseases.
- To engage in providing essential quality Primary Health Care services to the people in the designated areas.

### **Mobile Medical Unit for Endosulfan Victims:**

The National Health Mission is committed to provide affordable, accessible and quality health services to all. The Mission has a mandate to reach everyone, particularly the vulnerable and marginalized in the rural areas. While the endeavour of NHM and the State is to meet this commitment, there are population sub groups in inaccessible areas where our success has been only partial, such communities often stay out of the coverage area of

fixed facilities and are often deprived of mainstream services. Mobile Medical Units / Mobile Health Clinics are an innovation, to address these gaps, which will be able to provide a set of preventive, promotive and curative services at the door step of these Endosulfan Victims.

### **OBJECTIVES OF MOBILE HEALTH CLINIC PROGRAM:**

- To conduct a comprehensive and individual data generation by door to door survey in each panchayat and collecting the data base.
- Disease surveillance system with short and long term screening to the Endosulfan effected victims
- To provide curative services for common illness and chronic illness.
- To provide health education activities and environmental sanitation.
- To provide diagnosis, treatment and follow up of all chronic illness like diabetes mellitus, hypertension, chronic respiratory diseases, epilepsy, chronic arthritis and acid peptic.
- To identify the victims of Endosulfan & providing proper medical facilities to them.
- To provide 'pre-natal' scanning on expecting mothers from Endosulfan effected area
- To ensure assured fixed day care services in fixed locations for 6-8 hours a day in identified villages.
- To provide quality Primary Health Care services including referral services as per the objectives of MMU services.
- To provide door step treatment to Endosulfan affected victims with supporting staffs to handle them with care.
- To provide essential health care services for Endosulfan victims suffering from cancer, skin aliments, blindness, deafness and physically challenged health issues.
- To provide minimum Laboratory Investigation such as Urine for Alb & Sugar, Pregnancy test, Blood Sugar level estimation, Hemoglobin estimation etc.,
- To create awareness regarding communicable and non-communicable diseases and their prevention through IEC activities.
- To reduce Out of Pocket Expenditure of target populations.

### Pradhan Mantri Bhartiya Janaushadhi Pariyojana Kendra

Pradhan Mantri Bhartiya Janaushadhi Pariyojana Kendra (PMBJK) is a campaign launched by the Department of Pharmaceuticals, Govt. of India, to provide quality medicines at affordable prices to the masses through special kendras known as Pradhan Mantri Bhartiya Janaushadhi Kendra. Pradhan Mantri Bhartiya Janaushadhi Pariyojana Kendra (PMBJK) has been set up to provide generic drugs, which are available at lesser prices but are equivalent in quality and efficacy as expensive branded drugs. BPPI (Bureau of Pharma Public Sector Undertakings of India) has been established under the Department of Pharmaceuticals, Govt. of India, with the support of all the CPSUs for co-coordinating procurement, supply and marketing of generic drugs through Pradhan Mantri Bhartiya Jan Aushadhi Kendra. Currently, we are providing Janaushadhi Services at Sirsi, Kumta, Honnavar taluks of Uttara Kannada District.

### Vision:

To bring down the healthcare budget of every citizen of India through providing Quality generic Medicines at Affordable Prices.

**Mission:**

1. Create awareness among public regarding generic medicines.
2. Create demand for generic medicines through medical practitioners.
3. Create awareness through education and awareness program that high price need not be synonymous with high quality.
4. Provide all the commonly used generic medicines covering all the therapeutic groups.
5. Provide all the related health care products too under the scheme.

**Objectives of the scheme:**

Making quality medicines available at affordable prices for all, particularly the poor and disadvantaged, through exclusive outlets “Pradhan Mantri Bhartiya Janaushadhi Kendras”, so as to reduce out of pocket expenses in healthcare.

**KARNATAKA INTEGRATED URBAN WATER MANAGEMENT INVESTMENT PROGRAMME (KIUWMIP)****Package 1 -Exclusively for Davanagere ULB (24 months)**

The Karnataka Integrated Urban Water Management Investment Programme (KIUWMIP) aims to institutionalize mechanisms in the urban context that contribute to managing increasingly scarce water resources in a holistic and sustainable manner. Investment support will be provided to modernize and expand urban water supply and sanitation (UWSS) while strengthening relevant institutions to enhance efficiency, productivity and sustainability in water use. Innovations such as public-private partnership (PPP) will also be explored and implemented. The Programme will specifically seek to support 'greening' and inclusiveness agendas, as it targets assistance to more fragile environments increasingly affected by water resource degradation and often located in Karnataka's more economically lagging regions. The Programme proposes a multipronged approach combining to improve two outputs of expanded efficient urban water and sanitation Infrastructure and improved water resource planning monitoring and service delivery in Davanagere town.

## Objectives

- Communicating improved water and sanitation services in the ULBs under KIUWMIP and associated information about KIUWMIP.
- Communicating 100% households and other water users, including other stakeholders towards 24x7 water supplies.
- Communicating 100% households towards availing sewerage connections, including Toilets and about improved waste water collection and treatment systems.
- Conducting sanitation related awareness, Output Based aid (OBA) for Toilets targeting urban poor, and behavior change process to achieve open defecation free (ODF) communities across the ULBs.
- Communicating to all stakeholders about plans for various ULB reforms in water and sanitation services delivery.
- Communicating over the Gender inclusion elements and social/environmental safeguards
- Facilitating construction of Household and Community toilets, including connection to the sewerage network / alternate safe options proposed under OBA mode, only in exceptional cases.
- Facilitating use of newly constructed household toilets; including operation and maintenance of community toilets under proposed OBA mode.

### The following are the details of proposed package 1: Davanagere ULB

As of 2011 census, Davanagere city had a population of 4, 35,125. Males constitute 52% of the population, and females 48%. Davanagere has an average literacy rate of 85%, higher than the national average of 74.04% male literacy is 89% and, female literacy is 81%. In Davanagere, 12% of the population is under 6 years of age.

## IV. Agriculture, Watershed and Natural Resource Management

### Integrated Watershed Management Programme (IWMP) – Batch V & VI : Uttara Kannada District

Watershed management as a strategy has been adopted by Government of Karnataka especially in the rain fed regions of semi-dry tropics. These regions are characterized by low and un-dependable rain, low soil fertility, poor infrastructure development, low literacy and high incidence of migration. The low fertility of crops results in lower productivity of crops which have a very low biological efficiency. Several studies have identified that there is a dire need of a systematic and scientific approach to deal with watershed development.

From July 2016 to August 2018, implemented Integrated Watershed Management project Batch V & VI, in 3 sub watershed area of Uttara Kannada district. Geographical area of watershed covers 12000 hectares belongs to private and community lands covering 3 Sub watershed areas of Uttara Kannada District.

### **V. Disaster Management, Resettlement and Rehabilitation Flood Relief Management**

#### **Karnataka State Highway Improvement Project – III (Phase–III)**

The Public Works Department Government of Karnataka is implementing Karnataka State Highway Improvement Project – III (KSHIP III). Under this project 1200 km of State Highway roads have been identified for project assistance under Asian Development Bank. It is proposed to take up about 418 kms of the road length in the first instance under the road development works. The aim of the project is to improve the performance of the State's road transport sector by improving the road conditions and capacity, and to improve the State's capacity to plan, develop and maintain the Karnataka roads transport sector.

While implementing this project there will be various impacts on the people residing in that locality. The PWD has appointed two Detailed Project Report (DPR) Consultants who carry out Social Impact Assessments (SIA) and Resettlement Plans (RPs) in which they identify various categories of impact accruing to the people. The negative impact on the people include loss of land, structures, assets attached to the land or structures, loss of livelihood and loss to common property resources. Keeping in mind all the above negative impacts, the people affected adversely are to be addressed appropriately and resettled and rehabilitated accordingly.

The proposed project can be viewed as boosting economic growth and poverty reduction which will bring substantial social and economic development in the region. The social benefits arising due to the project will be triggered off due to improved accessibility to various services such as easy access to markets, health facilities, schools, workplace which in turn increases the income of the region, and ultimately elevating their standard of living. Although various positive project impacts and benefits are expected from the proposed project as mentioned above, there will be some negative impacts on the people living in the immediate project area.

The aim of Resettlement Plan (RP) is to mitigate negative impacts caused due to the project and resettle the displaced persons and restore their livelihoods. The Resettlement Plan has been prepared on the basis of census survey findings and consultation with various stakeholders.

The Resettlement Plan (RP) is a project specific RP, which outlines the extent of impacts due to road improvements on communities and the mitigation of the potential impacts. Further, it details necessary implementation procedures for resettlement and rehabilitation.

Keeping in view the impact to the people due to the implementation of the project, the KSHIP required appropriately resettling and rehabilitating the DPs in accordance with the Resettlement Plans (RP)s proposed for the purpose. For the implementation of the RPs, the KSHIP required to appoint NGO who not only have the experience in carrying out such activities, but also have a better access with the people at the grassroots for effective implementation.

In this contrast SCODWES has been shortlisted for the implementation of project at Karnataka India. Out of 3 packages, SCODWES has been shortlisted for PACAKGE-1.

- h. Any other tasks as assigned by KSHIP.

## Flood relief work at Kodagu

The rain which has ruined the Kodagu, the Kashmir of South and Scotland of India, which has changed the very landscape of the district. People who have built comfortable houses of their own and leading their life are washed away due to heavy rain and floods. They moved away from their land due to landslides and taking shelter in the relief centres. Lost everything they had. Hundreds of people, even amidst of heavy rain, have walked kilometers together and escaped from floods, thus saving their lives. Some of the families who have survived have taken shelter in their relatives' homes in the city. However, rains are nothing new to the Kodavas as almost every rainy season it really pours in the district. But this time it has ravaged the whole place with houses collapsing, coffee estates destroyed and huge hillocks coming down, roads washed away that has turned their life to the hell.

We, from SCODWES-Sirsi had extended a little possible helping hand in such a situation. The entire staff of SCODWES had collected the basic required things like blankets, bed sheets, readymade dresses, sarees, essential vessels, mugs, medicines and packed food items from the publics of Sirsi town who had donated whole heartedly. Apart from this, SCODWES had donated medicines worth more than a lakh of rupees worth. A group of 15 volunteers from SCODWES worked for 3 days in the flood hit areas of Kodagu from 20.08.2018 to 23.08.2018 headed by our Executive Director, Mr. Venkatesh Naik. Two vehicles were arranged to carry the goods collected and 1 Mobile Medical Unit along with 1 Doctor, 6 Nurses, 1 lab technician were serving the people for all the 3 days with medicines free of cost. With the message, "Stand with the people who are in distress".
